This position will be responsible for the implementation of activities to support effective area-based management to protect and restore biodiversity within a potential marine protected area. The Project Officer will work closely with our project partner and the WildAid Thailand team, government agencies, local communities, stakeholders, and conservation organizations to ensure the successful delivery of the project goals and raise awareness of sustainable marine ecosystem services.

#### **Key Responsibilities**

#### 1) Project Planning and Coordination:

- Develop and implement a comprehensive area management and monitoring plan for the project site.
- Conduct feasibility assessments and develop a roadmap for designating the project site • as a locally managed marine area (LMMA) in accordance with the Thai government frameworks and international standards.
- Conduct a feasibility study for an ecosystem restoration project that aligns with the project's conservation goals and sustainable use of ecosystem services.
- Coordinate with key stakeholders, including local communities and administrative authorities, central government agencies, NGOs, and other relevant organizations.
- Ensure the project achieves its objectives on time and in alignment with WildAid's conservation goals.

### 2) Community Engagement:

Foster stakeholder engagement and support. Identify key stakeholders, including local communities, government entities, and private sector partners, establish a plan and facilitate continuous consultation, collaboration, and ensure their active engagement in the area management throughout the project.
