- Global Leadership Opportunities: Hope for oceanic mantas, sea turtles, and sharks has become a reality as Panama and its neighbors take action against illegal fishers to safeguard one of the world's most critical migratory corridors. This year, Global Affairs Canada, the Bezos Earth Fund, and Pacifico further recognized our world-class enforcement leadership, providing powerful validation of our model and its global impact.


These are not isolated wins; they are proof that hope, combined with action, creates transformation. And they are only possible because of you.

## Leadership on the Global Stage

Winning HRH Prince William's prestigious Earthshot Prize was not just a historic milestone—it became a powerful catalyst for WildAid to expand our leadership and accelerate breakthroughs in conservation across the globe.

At the 10th Our Ocean Conference in Busan, South Korea, CEO Meaghan Brosnan showcased WildAid's cutting-edge enforcement model—proof that smarter patrols and stronger partnerships are transforming marine protection. She rallied global allies and announced a \$6 million investment to safeguard Latin America's ocean ecosystems, home to some of the richest biodiversity on Earth.

That momentum surged into another historic milestone when President and Chief Programs Officer John Baker led the signing of a landmark five-year partnership with Panama's Ministry of Environment. Backed by Global Affairs Canada, the Bezos Earth Fund, and Pacifico Foundation, this first-of-its-kind initiative in the Eastern Tropical Pacific is setting a bold precedent for regional collaboration to stop illegal fishing and defend some of the planet's most vital waters.

Together with practitioners, educators, and policymakers, we advanced wildlife-free alternatives and put sustainability at the heart of cultural traditions.

## **Why It Matters**

Pangolins are often called the "guardians of the forest." These quiet, armor-covered mammals are nature's caretakers, with each one eating up to 70 million ants and termites every year. In doing so, they protect crops, aerate soils, and nourish the forests that sustain life for countless other species—including us.

Yet these gentle creatures are also the most trafficked wild mammal on Earth. In the past decade alone, an estimated one million pangolins were poached from the wild. Their fate is inextricably linked to ours: to lose pangolins is to disrupt the delicate balance of entire ecosystems and threaten the well-being of communities that depend on healthy forests.

## **The Challenge**

Despite international trade bans and national laws protecting them, pangolins continue to be targeted by poachers and traffickers. In China and Vietnam, demand for pangolin meat and scales—driven by centuries-old medicinal practices and consumption as a cultural delicacy—sustains a global black market.

In Cameroon and across Central Africa, pangolins are still hunted as bushmeat and openly sold in restaurants despite their protected status. Their biology makes them especially vulnerable: pangolins reproduce slowly, often giving birth to just one pup at a time, and they rarely survive in captivity. Each loss is not just an individual tragedy but a step closer to extinction.



## **Our Solution**

At the heart of WildAid's approach is a guiding belief: saving pangolins depends on transforming human behavior. Laws alone cannot protect them if demand persists. That's why our strategy focuses on these key pillars—shaping culture, elevating pride, driving policy change, and strengthening enforcement—to make consuming pangolins and pangolin scales socially unacceptable and protecting them as a source of national identity.

Working alongside the traditional medicine community to encourage sustainable practices in Asia, we aim to reduce demand by reshaping cultural attitudes, enlisting beloved public figures, and sparking national conversations that reframe pangolins as species worth honoring, not consuming. Our campaigns inspire empathy and pride, while policy advocacy ensures these cultural shifts translate into systemic reform.

In Africa, where pangolins are hunted for bushmeat, our strategy centers on community pride and leadership. By collaborating with celebrated musicians, football icons, and traditional chiefs, we elevate the pangolin as a symbol of Cameroonian culture and forest guardianship. This cultural re-framing is reinforced by advocacy with restaurants and policymakers, ensuring that public pride becomes embedded in daily choices and national law.

Across both continents, our goal is to dismantle the forces driving demand while empowering local pride and governance to sustain long-term protection. By combining mass awareness with political will, WildAid is laying the groundwork for one of conservation's most significant turnarounds.

## **Why It Matters**

For over 2,500 years, Traditional Chinese Medicine (TCM) has been a key part of health and wellness in more than 180 countries. As it continues to grow in popularity worldwide, it has become a multi-billion-dollar industry.

However, the harsh truth is that many TCM remedies still depend on products from endangered wildlife, such as rhino horn, pangolin scales, tiger bones, and seahorses. This reliance drives a severe poaching and trafficking crisis across Asia and Africa. As demand for TCM increases, so does the risk to these vulnerable species. The time to shift this ancient practice toward sustainability is now, because it is crucial for protecting highly endangered wildlife.

## **The Challenge**

Deep-rooted cultural traditions and strong beliefs create major hurdles for conservation reform. Many practitioners and patients, especially older generations, still see wildlife-based remedies as essential for healing.





Misconceptions about their effectiveness are common, and poorly regulated markets enable both legal and illegal trade to thrive. Without a coordinated strategy and effort, rising demand for wildlife ingredients could lead some species to extinction.

## **Our Solution**

We are at a critical point in shaping the future of TCM and wildlife conservation. Lasting change must come from within the TCM community itself. Instead of opposing this ancient practice, we collaborate with practitioners, educators, and cultural leaders to develop a future-focused approach that integrates sustainability into the heart of TCM, ensuring its responsible growth in the modern era.

Our first step has been to support the formation of a coalition that brings together respected voices across Asia and beyond. By serving as Advisor to the Coalition for Wildlife Protection in TCM—and launching a Vietnam chapter during the 2025 international conference in Hue—we've laid the

foundation for a movement that crosses borders and generations. This coalition is creating a platform for dialogue and a shared commitment to replace wildlife products with safe, effective, sustainable, and culturally acceptable alternatives.

Education is key to our approach. Alongside Hue University of Medicine and Pharmacy, we are developing ongoing education programs that prepare the next generation of TCM practitioners to lead this change. The curriculum highlights plant-based remedies and therapies, such as acupuncture and massage, helping ensure that sustainability becomes a fundamental part of medical training, not an afterthought. Leadership from within the TCM community is also vital. WildAid involves respected scholars and practitioners—individuals whose authority commands trust—who speak out for wildlife protection. Their advocacy shows that protecting endangered species is not a rejection of tradition but an evolution of it.

Finally, we amplify these efforts through public engagement, including seminars, media coverage, and targeted campaigns that showcase effective, legal alternatives to wildlife products. By sharing practitioners' successes with using acupuncture or plant-based substitutes instead of rhino horn or pangolin scales, we demonstrate that healing and conservation can go hand in hand.

## **Why It Matters**

Every year, millions of travelers explore China, Southeast Asia, and beyond, often meandering through markets filled with ivory carvings, tiger teeth, and tortoiseshell goods. What may seem like harmless keepsakes usually come with severe consequences. Each purchase fuels the global illegal wildlife trade, intensifies poaching, and pushes endangered species closer to extinction.

Yet, travel presents a unique opportunity for education. Passengers on flights become a captive audience, ready to absorb impactful messages during their journey. The tourism industry has a pivotal role in promoting wildlife conservation through these travel experiences.

## **The Challenge**

Many tourists fail to connect their tokens of remembrance to the broader illegal wildlife trade. Each item bought contributes to a damaging supply chain that endangers some of the world's most vulnerable species. Once these products are acquired, they become difficult to intercept, leading to further harm to wildlife populations.

Our critical challenge is to engage travelers before they make these purchases, helping them understand the consequences of buying wildlife products and motivating them to choose alternatives.

### **Our Solution**

WildAid's strategy is clear: collaborate with the airline industry to integrate wildlife protection messaging into the travel experience. By partnering with airlines that carry millions of passengers across Asia, WildAid places crucial conservation messages where they cannot be overlooked—on in-flight entertainment systems, boarding passes, seatback pockets, overhead bins, airport lounges, and even through announcements by flight attendants. This method transforms downtime into meaningful



reflection, ensuring conservation messages reach passengers effectively. We also include engaging, child-friendly activities that make flights a learning opportunity about wildlife protection. Our message is powerful: "Bring home memories, not regrets."

## **Our Impact**

These corporate collaborations show that strategically placing conservation messages can influence tourist behavior on a large scale.



Defenders of the Hidden documentary with Wang Yibo introduced tens of thousands of Air China passengers to the plight of Chinese pangolins and the need to protect them, turning long flights into teachable moments about urgent wildlife issues.



200,000 boarding passes on China Southern Airlines carried the "Light Up Hope for Pangolins" message, an effort so impactful that it earned the airline the 2024 China Southern Airlines All-Media Cloud Navigation Award.



Our elephant ivory campaign with Yang Zi reached millions of Shenzhen Airlines passengers across 200 aircraft with 700 daily flights. In-flight PSAs, seat-back messages, and lounge promotions raised awareness of the illegality of ivory.

## Saving Tanzania's Lions from the Bushmeat Trade

Tanzania holds Africa's largest wild lion population, yet this legacy is under threat from the illegal bushmeat trade. Bushmeat is meat from wildlife, hunted for human consumption. Urban demand for bushmeat is fueling commercial poaching and indiscriminate snaring that kills thousands of animals every year—including vulnerable lions caught as bycatch. Unfortunately, researchers lack reliable data on who buys bushmeat, how suppliers provide it, and the true impact on wildlife and livelihoods.

WildAid is addressing this urgent gap by launching Tanzania's first nationwide research and strategy effort to

combat bushmeat demand. We are surveying consumers across seven cities, mapping supply chains, and pretesting compelling behavior-change messages with Tanzanian partners. This evidence-based approach will guide a national campaign to reduce demand, mobilize government and media, and inspire protective action rooted in Tanzanians' pride for their lions.

Already, this work is generating momentum among policymakers and conservation leaders who see the urgency of taking action.

## **Why It Matters**

Every year, II million tons of plastic enter our oceans. Nearly one-tenth of this plastic is discarded fishing nets—so-called "ghost nets." These nets drift invisibly beneath the surface, strangling whales, drowning sea turtles, and destroying coral reefs.

They also suffocate mangroves and seagrass beds, weakening ecosystems that support fisheries, buffer coastlines, and store carbon. Ghost nets are not only devastating marine biodiversity, but they also threaten the food security, safety, and livelihoods of coastal communities that depend on healthy oceans.

## **The Challenge**

Ghost nets are a slow-moving disaster: durable, deadly, and costly to remove. Once abandoned, they can "fish" for decades, killing indiscriminately while evading detection. They endanger divers, vessels, and tourists, yet awareness remains low, recycling solutions are scarce, and enforcement is inconsistent. For years, this crisis has been hiding in plain sight. This highly probable threat has gone largely unaddressed, including in China's nearshore waters.



## **Our Solution**

In 2024, WildAid launched *No Net Left Behind*—the first national campaign in China to confront ghost net pollution head-on. Rather than treating ghost nets as waste, we reframed them as a solvable challenge—one that demands innovation, collaboration, and a sense of cultural pride.



We began in fishing communities to expand recycling points and voluntary net retrieval. Alongside this, we championed creative recycling and repurposing efforts, transforming abandoned nets into art, fashion, and functional products that proved waste could be reimagined.

To reach the public, we partnered with Condé Nast Traveler and Youku to create a four-part docuseries. Two of China's most beloved figures—award-winning actor Huang Xuan and Olympic gold medalist Zhang Yufei—became "Ocean Guardians," diving into the issue, joining retrieval efforts, and showing millions of viewers how communities are leading the way in solutions.

We then built a coalition of powerful partners, from PADI, the world's largest diver training organization, to Weibo Charity and Youku, harnessing the reach of millions of divers, vast online audiences, and national media platforms. Together, this alliance has pledged to cut China's nearshore ghost nets in half and reduce abandoned gear waste by 80% within the next decade.

## **Our Impact**

No Net Left Behind reached hundreds of millions across China, transforming ghost net pollution from an overlooked issue into a national call to action. By blending media, art, and community leadership, WildAid proved that awareness can spark measurable environmental impact.

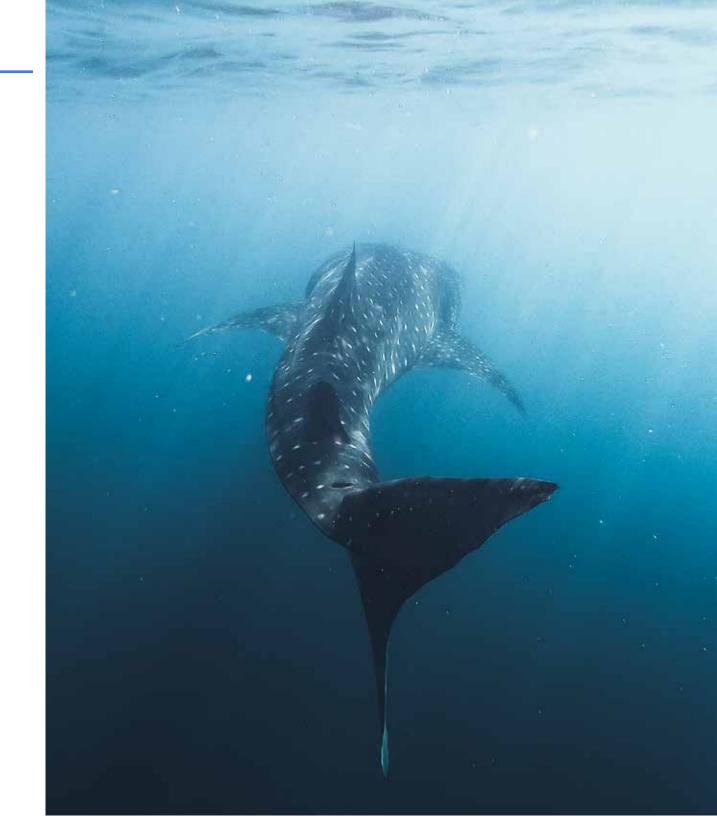

## 20 YEARS OF SHIFTING BEHAVIOR TO SAFEGUARD SHARKS

For over two decades, WildAid has led the charge to protect sharks, pioneering demand reduction campaigns and establishing world-class marine enforcement programs. By addressing both the root cause—human demand for shark products—and the urgent need for protection at sea, WildAid has transformed cultural norms, reduced shark fin consumption, and defended some of the planet's most critical shark habitats. This timeline tells the story of that journey.

## 2004 - 2012 Pioneering Shark fin Soup Campaign Launched

Launched in China featuring Yao Ming and Jackie Chan, our campaigns brought shark conservation to the global stage. Public awareness of shark finning soared from under 30% to over 80% in just three years. By 2013, shark fin soup had been banned at official banquets, marking a significant cultural and political turning point.





## 2013-2018 EXPANDING SHARK FIN DEMAND REDUCTION CAMPAIGNS

Expanding across Thailand and Hong Kong SAR, we secured commitments from airlines, hotels, and shipping lines to drop shark fin. Shark fin consumption in China plummeted by more than 80%, with younger generations leading the rejection.

## INNOVATIVE TOOLS HELP PROTECT ENDANGERED SHARKS

Our DNA testing in Thai markets exposed that two-thirds of shark fins came from endangered species, sparking national attention and driving a 34% consumption drop—8.1 million servings eliminated since 2017. Now, we're expanding our campaigns to tackle shark meat consumption, engaging youth and influencers to drive long-term change.

## A Legacy of Global Shark Conservation Leadership



The transformation is extraordinary. In China, demand for shark fin has plummeted by more than 80% since 2008. In Thailand, our campaigns have helped remove over 8 million bowls of shark fin soup from being served. And through expanded marine enforcement across 20+ coastal nations, we have safeguarded more than 2 million square kilometers of coral reefs, mangroves, and seagrasses—lifelines for sharks and for the health of our oceans.

Our work has demonstrated that behavior can shift, laws can be enforced, and societies can come together to protect sharks. Today, sharks stand as a fascinating, unifying force of global ocean conservation—and we are determined to keep it that way for the next twenty years.

## **Empowering Philippine Communities to Stop Blast Fishing**

The Philippines is home to the world's most diverse coral reefs, boasting more than 600 species of coral, 2,000 species of reef fish, and six of the world's seven marine turtle species. But this abundance is on the brink.

Blast fishing and cyanide poisoning shatter coral that takes centuries to grow, leaving graveyards where vibrant reefs once thrived. Despite decades of progress, these destructive practices persist in Philippine waters. Homemade explosives shatter coral that takes centuries to grow, and toxic chemicals suffocate marine life.

We've trained and equipped more than 80 Bantay Dagat—local "Guardians of the Sea"—to defend their reefs. With support from the Canadian Embassy, we provided essential dive gear and an undercover vessel to the Philippine National Police Maritime Group, equipping officers with the tools to recover evidence, catch offenders, and hold them accountable.

Our goal is to build reef resilience and strengthen every link in the enforcement chain—protecting Philippine reefs for generations to come.

## **Why It Matters**

São Tomé and Príncipe—often called the "Galapagos of Africa"—harbors some of the richest marine biodiversity on Earth.

Its reefs, mangroves, and seagrass beds shelter five of the world's seven sea turtle species, serve as seasonal grounds for humpback whales, and support hundreds of coastal communities. For the island nation, the ocean is not only a wildlife sanctuary but also the foundation of food security, cultural heritage, and economic survival. Protecting these waters safeguards both nature and people.

## **The Challenge**

Despite its ecological importance, São Tomé and Príncipe's oceans face mounting pressure from illegal, unreported, and unregulated (IUU) fishing, habitat degradation, and climate change. Semi-industrial fleets undermine small-scale fishers who depend on the sea. At the same time, weak laws, scarce patrol resources, and limited coordination across agencies leave ocean enforcement in a fragile state.

## **Our Solution**

In 2023, WildAid joined a coalition of partners to help São Tomé and Príncipe chart a new course for its oceans by establishing the nation's first network of eight marine protected areas (MPAs). Our approach ensures these MPAs are more than lines on a map—grounded in both government authority and community participation.

We began with a fisheries enforcement gap assessment to identify where the system was breaking down, from legal loopholes to equipment shortages. Working with policymakers, we closed critical gaps in MPA decree laws to grant enforcement agencies real powers of detention and seizure. In April 2024, we convened all enforcement bodies for the nation's first national table-top exercise, running

through violation scenarios to prepare for real-world operations and laying the groundwork for a unified Manual of Operations.

Just as importantly, we designed a citizen vigilance program to bring communities into co-management, training local fishers and NGOs as "Sea Guardians." This initiative strengthens trust and compliance while extending the reach of ocean patrols. Together, these efforts are forging a system where government and communities stand side by side to defend their seas.





## **Our Impact**

São Tomé and Príncipe is on the path to safeguarding its globally magnificent biodiversity. Even in its early stages, this initiative has achieved critical breakthroughs:

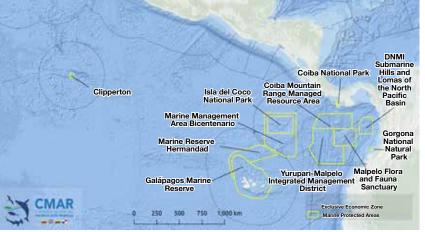
## **Why It Matters**

Panama lies at the very heart of the Eastern Tropical Pacific (ETP). In this marine corridor, sharks, sea turtles, whales, and tuna migrate, breed, and feed. Its waters include critical nesting beaches, vibrant coral reefs, and productive fishing grounds that sustain both biodiversity and local livelihoods.

For Panamanians, the ocean is a cornerstone of culture, food security, and economic growth. Yet, illegal, unreported, and unregulated (IUU) fishing increasingly threatens these same waters, undermining both ecosystems and the communities that depend on them.

WildAid's Marine Program is working with government and local partners in the Eastern Tropical Pacific to secure a vast ocean area comprising 11 marine protected areas totaling more than 640,167 sq kms, about the size of Texas, where migratory wildlife, including many species of sharks, whales, sea turtles, and mantas, swim freely.

## **The Challenge**

Despite decades of progress in designating marine protected areas (MPAs), Panama's seas remain vulnerable. Industrial fleets—including "dark vessels" that disable tracking systems—continue to exploit protected waters. Enforcement agencies face limited resources, fragmented monitoring, and unclear jurisdiction. Without stronger coordination and practical tools, illegal operators can evade patrols, plunder fish stocks, and compromise the resilience of marine ecosystems against climate change.

## **Our Solution**

In March 2025, WildAid launched Strengthening Marine Enforcement in the Eastern Tropical Pacific Seascape—a groundbreaking regional initiative supported by Global Affairs Canada, the Bezos Earth Fund, and Pacifico. This program brought together leaders from Panama, Costa Rica, Colombia, Mexico, and Ecuador to share expertise, strengthen

coordination, and adopt new technologies to combat illegal fishing. Among the most potent tools introduced was the Dark Vessel Detection platform, developed by Canada's Department of Fisheries and Oceans, which enables real-time monitoring of vessels that switch off their tracking systems to evade enforcement.

At the center of this regional effort is Panama, where WildAid signed a landmark five-year agreement with the Ministry of Environment—our first formal partnership with the government. Together, we are closing enforcement gaps, training officers through scenario-based exercises, deploying advanced monitoring systems, and empowering coastal communities to act as partners in protecting their coastal areas. By combining cutting-edge technology, international cooperation, and local engagement, we are equipping Panama to safeguard its extraordinary marine biodiversity for future generations.

## **Our Impact**

Our work in Panama has delivered major milestones, including both national breakthroughs in Panama and regional progress across the Eastern Tropical Pacific:



First-ever Landmark Agreement in Panama: Signed our first-ever formal partnership with Panama's Ministry of Environment, securing a five-year commitment to strengthen marine protection and combat IUU fishing.



Seizure of Six Illegal Longline Vessels: Supported Panamanian authorities following the seizure of six illegal longline vessels by advancing MCS systems and strengthening interagency coordination.



Five-Country Regional
Collaboration Launched: Convened
representatives from Costa Rica,
Panama, Colombia, Mexico,
and Ecuador to initiate crossborder cooperation, training, and
experience-sharing in marine
enforcement.



Cutting-Edge Technology Deployed: Introduced advanced Dark Vessel Detection platforms and satellite tracking tools to Panama and ETP partners, enabling real-time monitoring of illegal fishing activity.

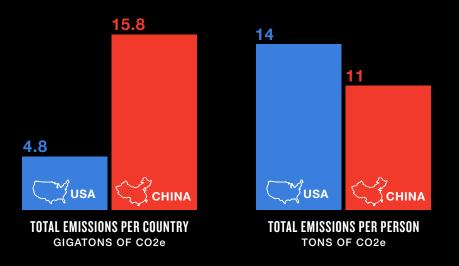

## **Climate: The Defining Challenge**

For decades, illegal trading and poaching defined the frontline of WildAid's work.

Today, an even greater threat looms over everything we do: climate change.

From forests to coral reefs, from elephants to sharks, iconic species and their habitats are caught in a web of rising temperatures, deforestation, floods, and droughts. And these threats continue to rise.

For over 20 years, WildAid has been the world's leading environmental communications organization, reducing demand for wildlife products and challenging carbon-intensive lifestyles. Our success isn't just about visibility. WildAid's unique media model integrates consumer insights from top research institutions, creative concepts from world-class agencies, and unparalleled reach through leading advertising platforms. Because our campaigns are high-quality, celebrity-driven, and proven effective, many partners contribute their support on a pro bono basis. As a result, every dollar we spend on production yields an average of \$85 in global media distribution.

In the climate arena, WildAid employs a similar model to shift public perceptions and promote sustainable choices. Just as wildlife trafficking is fueled by consumer demand, so too is climate change—through high-emission lifestyles. When trusted figures champion solutions and deliver clear, consistent messages, people are more likely to adopt climate-friendly behaviors and back policy changes.

This work is especially important in China and the United States. In China, progress depends on helping individuals recognize their ability to reduce emissions through everyday choices. In the U.S., the priority is breaking the cycle of silence and polarization that stifles climate conversation and action. In both cases, bold, national-scale media campaigns are essential to creating the cultural momentum needed for lasting change.

Lasting change requires more than science or policy it requires a shift in culture. WildAid specializes in making conservation and climate action visible, relatable, and aspirational at scale.

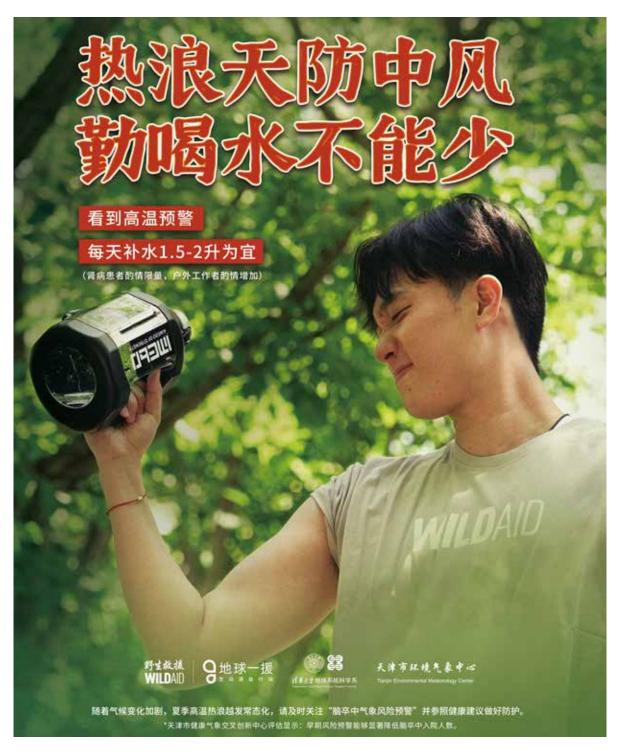

## **Why It Matters**

Rising seas, severe storms, and extreme heat threaten lives and livelihoods worldwide. Vulnerable groups such as children, seniors, outdoor workers, and low-income families bear the heaviest burden, often with the fewest resources to prepare for emergencies.

When individuals and communities are unprepared, the consequences can be devastating: health threats, loss of lives, displaced families, and damaged ecosystems. With the right tools and increased capacity to change behaviors and prepare collectively, people can build resilience that safeguards their health, security, and dignity amid a changing climate.

## **The Challenge**

Despite global commitments to climate action, local readiness remains dangerously limited. Many people fail to act on early warnings for extreme weather or underestimate climate-related health risks Community leaders, volunteers, and social workers are often undertrained and under-resourced. Weak coordination across agencies leaves preventable gaps.

Without urgent investment in community-level preparation and behavior change, climate action risks remaining abstract promises rather than lifesaving protections.

## **Our Solution**

WildAid partnered with the Harmony Community Foundation to launch the Community Health Risk Prevention Handbook series—the first of its kind in China—designed to help families and frontline workers prepare for extreme weather. The handbooks provide step-by-step guidance for six types of severe weather—heat waves, floods, typhoons, cold waves, blizzards, and sandstorms—so communities know how to act before, during, and after disasters.





The program also supports those on the frontlines of resilience, including volunteers, social workers, and neighborhood leaders. By equipping them with practical knowledge and coordination strategies, the project turns community networks into lifelines of protection.

To ensure information is accessible and credible, WildAid worked with leading scientific and medical institutions, including Lancet Countdown Asia, Tsinghua University, China's Meteorological and Medical Health Committee. To reach the broadest audience, we combined traditional outreach with creative innovations—from martial-arts style comics that engage youth to targeted digital alerts on platforms like Huawei Weather and Weibo.









## **Our Impact**

We are inspiring millions to take individual action to address climate change in their daily lives and empowering individuals with knowledge and tools to foster stronger, more resilient communities with an outsized impact.

**8.1+ million** interactions through the Climate Action Inspiration Station across multiple provinces.

**26 million** views of climate-health social media campaigns.

365,000 Huawei Weather users reached, including 135,000 vulnerable residents during extreme heat and cold events.

## **Why It Matters**

Most Americans care deeply about climate change—88% of Americans surveyed—support climate action, and 64% say they have already been directly affected by extreme heat in the past five years.

Yet despite this overwhelming concern, the vast majority of us remain silent and inactive. Two-thirds of Americans rarely or never talk about climate change, even with close friends and family. This silence creates the illusion of indifference and isolates people who actually share the same values.

Discussing climate change is one of the most straightforward and powerful steps we can take. Conversations normalize concern, connect local experiences to global changes, and make action contagious. By sharing our personal stories—how heat waves affect our children and seniors, how



wildfire smoke alters our seasons, how wildlife is changing in our own backyards—we transform climate change from an abstract threat into something immediate, human, and solvable.

## **The Challenge**

The greatest barrier to climate action in the U.S. isn't a lack of support—it's the misperception of support. Americans consistently underestimate the number of their peers who believe in and support climate-positive actions. For example, 75% of Americans support a carbon tax, but when asked, people estimate that only 30% do. Similarly, 92% support reducing food waste, yet most assume fewer than two-thirds share this value. This "perception gap" leaves people feeling isolated in their beliefs, making them less likely to speak up or take action.

Without breaking this silence, overwhelming public support and climate action risks going untapped. The challenge is clear: we must help Americans recognize they are not alone—and give them the tools and confidence to start conversations that lead to action.

## **Our Solution**

In 2025, WildAid launched Climate Conversations, building on the success of our U.S.-based campaign, The Environment Excuse. This initiative sparks meaningful dialogue about climate change by providing people with easy entry points to initiate discussions.

At the heart of this initiative is storytelling. Research shows that stories rooted in lived experience move people more than facts alone. Just as the stories of Tilikum the orca, Cecil the lion, and Kulu the pangolin inspired global conservation movements, personal stories of climate impact and resilience can drive a groundswell of change.

Nearly 9 in 10 Americans already support climate action. Still, most are surprised to learn they are in the majority closing this perception gap empowers people to speak up and to take action.



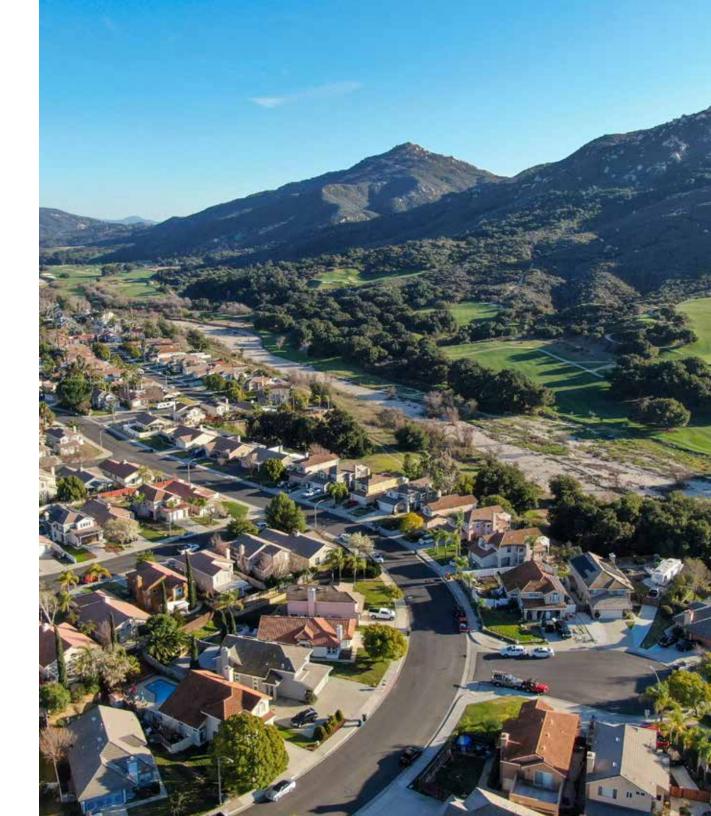
